

AGREEMENT FOR THE EXHIBITION TITLED
YOUNG ITALIAN ARTISTS AND FOR THE RELATED EVENTS: INAUGURATION,
CONCERT AND LIGHT SHOW ON 30 JANUARY 2019

This Agreement is made on this 16th day of January 2019 BY AND BETWEEN the Italian Embassy Cultural Centre, 50-E Chandragupta Marg, Chanakyapuri, New Delhi-110021 represented by Dr. Andrea Baldi, Director, hereinafter referred to as "Istituto" (which expression unless excluded by or repugnant to the subject or context shall mean and include its successor-in office and assigns) of the ONE PART;

AND

Basu Foundation (basufoundationarts@gmail.com) 65/5-F, Bagh Bazar Street, Kolkata 700003, represented by Mr. Abhishek Basu, Director, hereinafter referred to as "Basu Foundation" (which expression unless excluded by or repugnant to the subject or context shall mean and include its successor-in office and assigns) of the OTHER PART.

WHEREAS Basu Foundation has approached and proposed to Istituto to

- i. host an exhibition titled 'Living in the Cthulucene' comprising varied medium artworks of Italian artists Ră Di Martino, Lulù Nuti, Donato Piccolo, Luca Pozzi, Pietro Ruffo & Alessandro Twombly curated by Mr. Valentino Catricala, in the Foyer of the Italian Embassy Cultural Centre New Delhi.
- ii. create and install Light Installation at the entrance of the Cultural Centre with the support of the Italian designer Andrea Anastasio.
- iii. to organize a concert by the Italian Saxophonist Gianni Denitto coinciding the inauguration at 7 p.m on 30th January 2019.
- iv. Video Presentation by Stefano Curto

AND WHEREAS Istituto, having favorably considered and accepted the above Proposals of Basu Foundation;

NOW IT IS HEREBY AGREED TO BY BOTH THE PARTIES AS FOLLOWS:

Istituto undertakes to:

1. Provide foyer, multimedia hall and open space at the entrance for the exhibition, for the concert and for the Light Installation;
2. Bear and provide for electricity and security concerns and assistance of electrician and helpers wherever necessary;
3. Host the inauguration of the exhibition with a grand reception for about 200 invitees drawn from the mailing lists of the Istituto and the Foundation;
4. Provide audio and other stage requirements for the concert;
5. Bear the cachet of the curator of the exhibition Mr. Valentino Catricala (Prot:046 of 16.1.19);
6. Bear the expenses on international travel, boarding and lodging and local transport at New Delhi of the designer Andrea Anastasio.

Basu Foundation undertakes to:

1. Bear all the expenses related to transport, setting up and dismantling of the exhibition, insurance if

- any of the exhibits and all other related expenses of the exhibition and video by Stefano Curto;
2. Bear all the expenses related to the cachet of the Saxophonist Gianni Denitto, his visa cost, his international travel, his boarding and lodging in Delhi, his local transport and all such expenses related to him;
 3. Bear all the expenses related to creation and installation of the Light Installation at the entrance of the Cultural Centre with the assistance of the designer Andrea Anastasio.

Amendment to the Agreement

Any amendment to this Agreement will be effective only if it is agreed in writing and signed by the duly authorized signatories of the two parties:


Settlement of Controversies

Consultations


Any matters not provided for in this Agreement shall be dealt with through consultation between the parties hereto.
