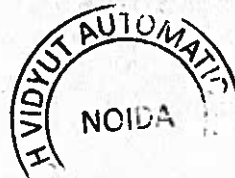

The present agreement does not entail any direct employment between the staff employed by your Firm and the Italian Embassy Cultural Centre.


Your Firm cannot lease to others, in whole or in part, the implementation of the work, which is the subject of the present agreement.

Payment will be made after the works are completed to the satisfaction of this Office and on your presentation of an invoice along with a work completion certificate.

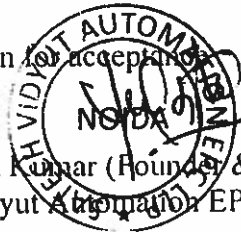
This contract is prepared in two (2) pages.
